JUDGMENT ON SPECIAL VERDICT

This action came on regularly for trial on January 25, 2010 in Department 62 of the above-entitled Court, the Honorable Michael L. Stern, Judge of the Superior Court, presiding. Attorney Gary S. Casselman appeared for plaintiff Adetokunbo Shoyoye. Attorney Thomas C. Hurrell appeared for defendant County of Los Angeles.

A jury of twelve persons was regularly impaneled and sworn and agreed to try the cause. Witnesses were sworn and testified. 4 **Question No. 1:**

5 Did the County of Los Angeles hold Adetokunbo Shoyoye in custody?

19 **Question No. 4:**

20 Did the employee(s) of the County of Los Angeles intentionally act or fail to act  
21 with plaintiff Adetokunbo Shoyoye's right to be free from the unreasonable seizure by  
22 actual or implied use of threats, intimidation or coercion?

2           Was the County of Los Angeles' employee(s)' conduct in violating plaintiff  
3 Adetokunbo Shoyoye's right to be free from unreasonable seizures a substantial factor  
4 in causing harm to plaintiff Adetokunbo Shoyoye?
